#### **Abstract**

The West Bengal government initiated the Lakshmi Bhandar Scheme in 2021 to give the state's women an opportunity for financial support. The West Bengal government has introduced measures to ensure the development and prosperity of all its women through various types of schemes, such as Lakshmir Bhandar, Kannyashree, Ruposhree, etc. An admirable initiative to encourage financial inclusion among West Bengali women is the Lakshmi Bhandar Scheme. The scheme's main goal is to give women direct cash transfers so they can get over financial obstacles and enhance their general quality of life. By providing women with increased financial power, the government intends to reduce poverty, foster gender equality, and boost the participation of women in a range of socioeconomic spheres. This research paper was carried out to measure the impact of lakshmir Bhandar scheme on empower women economically in jhargram district. This study is basically descriptive survey type in nature and it is conducted on two hundred beneficiaries of Lakshmir Bhandar scheme. A self-developed interview schedule was used to collect the data from the selected samples. The finding of the study revealed that the Lakshmir Bhandar has been important role on empowering women economically in jhargram district.

In the present era, with the active engagement of women in every sphere of life, it is often assumed that women in India are fully empowered. Women empowerment refers to the process of enabling women to gain control over their lives, make informed decisions, and exercise their rights and freedoms.

- Supporting women's reproductive rights and access to safe abortion.
- Empowering women to make informed choices about their lives and bodies.
- Promoting women's participation in decision-making and policy-making processes.

Women have historically faced a variety of complex obstacles that have frequently impeded their advancement in both the social and economic spheres within the complex fabric of West Bengal's cultural legacy and varied economic environment. The government of West Bengal has introduced a notable initiative for providing a financial support system to the female head of the household. This welfare scheme called "West Bengal Lakshmir Bhandar Scheme -2021. Planned with the overarching aims of empowering female and addressing gender-based economic disparities, this innovative welfare scheme has garnered significant attention for its potential to bolster financial stability and enhance the socio-economic status of women across the state.

The Lakshmi Bhandar Scheme stands out as a light of hope in response to these pervasive injustices, aiming to provide a supportive atmosphere that encourages women's financial autonomy, self-sufficiency, and socioeconomic empowerment in the area. The West Bengal government has initiated this transformative scheme that extends financial support to Scheduled Caste and Scheduled Tribes families, endowing them with Rs. 1000 to meet their personal expenses, while women of the general category receive Rs. 500 (cited as in Pratichi trust, 2023).

#### **Review literature**

A literature review goes beyond summarizing individual studies, including evaluating the study's strengths and weaknesses, discussing the credibility and reliability of sources.

Chatterjee (2023). Analysed on 'The Role of Lakshmi Bhandar Scheme in Improving Financial Inclusion for Women in West Bengal: A Review'. It is clear that the West Bengal government is devoted to ensuring the development and prosperity of all its citizens.

**Pratichi (India) trust (2023).** Title of the report 'Flow as Security: An Assessment of Lakshmir Bhandar Scheme'. The present assessment of Lakshmir Bhandar scheme was sponsored by the Department of Women and Child Development and Social Welfare, Government of West Bengal, also discussed that how woman's use the Lakshmi Bhandar money. This research work was conduct through case study method.

**Rakshit** (2023). wrote an article on the title Empowering Women through Lakshmi Bhandar Scheme: A Study of Maynaguri CD Block in West Bengal. This study has been planned to assess its impact on women in West Bengal. The findings of this study revealed commendable efficacy in empowering women economically and socially. By providing them with financial assistance, the scheme has enabled women to have greater control over their lives, fostering a sense of independence and autonomy.

This research used a descriptive survey design approach to investigate Impact of Lakshmi Bhandar Scheme to Women Empowerment. According to Landman (1988) descriptive research is thus a type of research that is primarily concerned with describing the nature or conditions and degree in detail of the present situation. (as cited in Mangal & Mangal, 2015). In survey research design the researcher administer a survey to sample or to the entire population of people to describe the attitude, opinions, behaviors or characteristics of the population. (as cited in Creswell, 2015).

All women who are getting lakshmir Bhandar money of jhargram district are considered as the Population for the present Study

# Sample of the study

One block taken out of eight blocks in jhargram district has been drawn for research through purposive sampling techniques. Then the researcher taken 200 lakshmir Bhandar recipients out of 4543 in jhargram district, through simple random sampling method. after designing sampling frame researcher visited 200 lakshmir bhander recipients and collected data.

#### **Research Instrument and Procedure**

Researcher was preparing structure interview schedule and apply it on Lakshmir Bhandar beneficiary. In this way researcher was collect the whole data needed for her research analysis, the interview schedule consisted of Nine items, are closed ended questions, have consist of Yes and No. The researcher also used used one open-ended question in this research.

## Data analysis techniques

The data were analyzed with the help of descriptive statistics and pie diagram.

#### **Delimitation of the study**

- i)The study was delimited to jhargram block in jhargram district of West Bengal.
- ii) The study has been confined only 200 sample within jhargram block.

#### Data analysis and interpretation

#### Objectives: 1 To review the aims and objectives of Lakshmir Bhandar scheme.

- I) On July 1st, 2021, West Bengal's Chief Minister, the esteemed Mamata Banerjee, launched the Lakshmi Bhandar Scheme. In this initiative, the West Bengal government provides Scheduled Caste and Scheduled Tribes families with Rs. 1000 for their personal expenses, and Rs. 500 to women of the general category. The goal of this scheme is to provide muchneeded financial assistance to the women of the state. This is a major step forward in the fight against poverty and inequality, and will no doubt have a positive impact on the lives of many. This scheme is focused on giving women access to local, organic, and nutritious products, as well as improved access to prices (as cited in Chatterjee, 2023)
- II) Conditions for inclusion under Lakshmir Bhandar In every such household, all female members will get the benefit, if 1) She is a resident of the estate of west Bengal .2) She is aged between 25-60 years.3) She is not a government employee in permanent employment / retired government employees of central / state government, statuary bodies, government undertaking, panchayats, municipal corporations, local bodies, teaching and non-teaching employees of government aided educational institutions etc. receiving regular salary/pension (cited as in Women and child development and welfare department, 2021)
- III) A literature review of the Lakshmi Bhandar Scheme in West Bengal highlights the objective of the scheme and its impact on alleviating poverty and empowering women in the region. The scheme, launched



The Lakshmi Bhandar Scheme is, all things considered, a very promising program for West Bengali women. The program will undoubtedly assist these women become empowered and eventually attain financial independence by offering financial support (as cited in **Das,2023**)

V) The Lakshmi Bhandar Scheme effects on women's economic and social empowerment indicators such as financial inclusion, poverty reduction, and women's participation in economic activities, it aims to provide evidence-based findings that contribute to the ongoing discourse surrounding gender-focused development policies (as cited in Rakshit,2023)




















 The survey result found that the Lakshmi Bhandar Scheme had an effect on women's economic and social empowerment indicators such as financial inclusion, poverty reduction, and women's participation in economic activities.

- Majority of women beneficiary said that Lakshmir Bhander scheme sustain her economic prosperity.
- 77 % of women use lakshmir Bhandar's mony for various kinds of productive work and some also do small businesses. such as said they used it for Bakhar- Hadia Making, Vegetable shop, Small Poultry farming, Mat Making, Sal Pata (leaf) Plate Making, Pickle Making.
- 78% of the study sample said that they had opened bank accounts with the help of the Lakshmir Bhander scheme, which is a major contribution to financial progression and inclusion.
- 60% women beneficiary said that money from Lakshmir Bhandar helped them to increase their self-esteem and self-reliant.
- 70% of women beneficiary said that they can spend this Lakshmir Bhandar money on their own like children's education, medical treatment etc.

#### **Conclusion:**

The survey was conducted with a sample size of 200 females below the poverty line who were enrolled in the scheme. The survey was conducted in Jhargram block located in the jhargram district. The results of the survey were interesting and indicative of the scheme's effectiveness in achieving its goals. The results showed that the Lakshmi Bhandar program was effective in helping women from low-income families. Most of the women beneficiary support this Lakshmir Bhandar Project. Overall, the survey showed general acceptance of the Lakshmi Bhandar program, but majority of women beneficiary said they are not satisfied with the money they get.
